Renewal Instructions for Membership Year 01 July 2019 to 30 June 2020

Membership Renewal consists of a completed membership renewal form and payment of respective fees.

By payment of membership:

A member agrees to the sharing of contact details with other club members.

The use of photos of the member, any associate, guest or vehicle taken at club events in club promotion including club magazine and social media (eg club website, club Facebook page).

Membership Days

Membership Days will be held between 10 am and 2 pm at clubrooms on the following days:

4th May 2019, 19th May 2019, 8th June 2019

These days allow members to submit their renewal forms and make payment in person.

It is recommended that members with vehicles with CONDITIONAL REGISTRATION attend a membership day with their logbooks and registration papers as Conditional Registration Officers will be available to process the required paperwork.

Payment of Fees

Methods of payment are:

1. At a Membership Day, payment by Card (Savings, Visa or Mastercard), Cheque or Cash.

A receipt will be emailed for payments by EFT and cheque and given in person for payments made at a Membership Day.

Conditional Registration for Historic Vehicles

In order for your Conditional Registration to continue, please ensure you have done the following **by 30th JUNE 2019**:

1. Paid your **membership renewal** (proof will need to be sighted by a Conditional Registration Officer).
2. Had your **logbook stamped** (endorsed) by a Conditional Registration Officer.
3. Had your **current registration papers stamped** for the Conditional vehicle (can be done at same time as logbook).

If any of these have not been done by **30th JUNE** your vehicle will be UNREGISTERED regardless of having a current registration certificate from Services SA/DPTI. The club is LEGALLY OBLIGATED to inform the registrar of motor vehicles of any members who have not renewed (as valid club membership is a condition of having Conditional Registration). NOTE: If you are attending membership day to have your logbook stamped, please bring your payment (or payment proof) with you so that the Conditional Registration Officers can verify that you have renewed. This needs to be done before your logbook can be stamped. Please allow adequate time for your payment to be received if sending a cheque by mail or paying by EFT.
